The schedule of items and quantity required for the entire work as calculated by NA Quantity Surveyor* appointed by Developer/Engineer, the assumption of the cost of material, labour and other inputs made by the developer, and the site inspection carried out by us to ascertain/confirm the above analysis given to us.

We estimate Total Estimated Cost of completion of the aforesaid project under reference at **Rs. 30, 46,64,696/-** (Rupees- Thirty Crore Forty Six Lakh Sixty Four Thousand Six Hundred Ninety Six Only) (Total of Table A and B) at the time of registration. The estimated Total cost of project is with reference to the Civil, MEP and allied works required for completion of the apartments and proportionate completion of internal & external works of the project as per specifications mentioned in agreement of sale and
