  period shall be in no case exceed three years provided further that such lapse shall not bar any subsequent
  application for fresh permission under section 44 of the Maharashtra Regional and Town Planning Act. 1966.
- (D) This Certificate is liable to be revoked by the C.E.O. (SRA) if ... The development work in respect of which permission is granted under this certificate is not carried out or the use thereof is not in accordance with the sanctioned plans.
- 0 Any of the condition subject to which the same is granted or any of the restrictions imposed by (SRA) is contravened or not complied with
