1. That the Promoter i.e. SMGK Developers Pvt. Ltd. has a legal Title Report to the land or ground situate, lying and being in the Revenue Village of Bandivali, Taluka Andheri, Mumbai Suburban District bearing C.T.S. Nos. 31E/5, 31E/5/1 to 31E/5/23 now new C.T.S. Nos. 31E/2D ("the said Land") on a portion of which the development of the project "SMGK URBANA - HEIGHTS" ("the Real Estate Project") is proposed.

A legally valid authentication of title of the said Land is provided/uploaded by the Promoter with "Form-A" – Application for Registration of Project" with the Maharashtra Real Estate Regulatory Authority ("Authority").
