1. I, **Mr. Girish Daiya** have undertaken assignment of certifying Estimated Cost for '**Proximus**' having MahaRERA Registration Number **P51800027318** situated on the Plot bearing CTS No. 1065, 1065/1 of village Chembur, demarcated by its boundaries (latitude and longitude of the end points) (North West lat- N19°03' 24.69667" longi- 72 53' 54.05222", North East lat- N19°03' 24.68981" longi- 72 53' 54.81508", South East lat- N19°03' 23.27885" longi- 72 53' 54.78365", South West lat- N19°03' 23.29592" longi- 72 53' 54.01860" of the end points) 11th Road to the North, CTS No. 1066, 1067 to the South, CTS No. 1064 to the East & 1069 to the West of village Chembur, taluka Kurla, District Mumbai Suburban, PIN - 400 071 admeasuring **959.00 sq. mts.** area being developed by **M/s. GeeCee Ventures Limited**.
2. We have estimated the cost of Civil, MEP and allied works required for completion of the apartments and proportionate completion of internal & external works of the project as per specifications mentioned in agreement of sale. Our estimated cost calculations are based on the drawings / plans made available to us for the project under reference by the Developer / Consultants. The Schedule of items and quantity required for the entire work as calculated by **Mr. Pravin Rode**, Quantity Surveyor* appointed by Developer/Engineer, the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us to ascertain/ confirm the above analysis given to us.
3. We estimate Total Estimated Cost of completion of the aforesaid project under reference at **Rs.16.50 Crores** (Total of Table A and B) at the time of Registration. The estimated Total Cost of project is with reference to the Civil, MEP and Allied works required for completion of the apartments and proportionate completion of internal & external works, as per specifications mentioned in agreement of sale and for the purpose of obtaining occupation certificate / completion certificate for the Building(s)/Wing(s), Layout/Plotted Development from the MCGM being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
4. The Estimated Cost Incurred till date is calculated at **Rs. 16.24 crores** (Total of Table A and B). The amount of estimated cost incurred is calculated on the basis of input material / services used cost of these items.

5. The Balance Cost of Completion of the Civil, MEP and Allied works for completion of the apartments and proportionate completion of internal & external works, as per specifications mentioned in agreement of sale, of the Project is estimated at **Rs. 0.26** (Total of Table A and B).
6. I certify that the Cost of the Civil, MEP and allied work for the apartments and proportionate internal & external works, as per specifications mentioned in agreement of sale, of the aforesaid Project as completed on the date of this certificate is as given in Table A and B below:
