2	The Total funds collected from allottees have been derived from the unaudited books of accounts, as presented by the management of the promoter. On a comprehensive assessment of the promoter's books of accounts, it has come to light that the promoter partially maintains a Designated RERA Bank account for the project at HDFC Bank, bearing account number 50200064903682, as mandated by Section 4(2)(1)(D) of the Act.
3	The Total short deposit in RERA collection account amounts to Rs. 2,04,86,432. Out of which, an amount collected from allotees amounting to Rs. 1,04,99,000/- were firstly received in current account of the promoter and subsequently corrected by transferring an amount equivalent from current account to RERA collection account. such, subsequent correction has been considered to be shortfall and refrence has been made in Annexure A.
