- 3) We estimate Total Estimated Cost of completion of the building of the aforesaid project under reference as Rs 23.89 Cr (Total of Table A and B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required for completion of the Building, completion of internal & external works of the as per specifications mentioned in agreement for sale for the purpose of obtaining occupation certificate / completion certificate for the building from the BMC being the Planning authority under whose jurisdiction the aforesaid project is being implemented.
- 4) The Estimated Cost Incurred till date is calculated at Rs 1.92 Cr (Total of Table A and B). The amount of Estimated Cost Incurred is calculated on the basis of input materials / services used.
- 5) The Balance cost of Completion of the Civil, MEP and Allied works for completion of the Building, completion of internal & external works of the as per specifications mentioned in agreement for sale of the project is estimated at Rs 21.97 Cr (Total of Table A and B).
