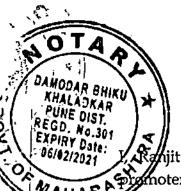

Affidavit cum Declaration of Mr. Ranjit Dattaji Naiknavare, a designated partner of Naiknavare Township LLP, promoter of the proposed project vide its/his/their authorization dated 15/05/2017.



V. Ranjit Dattaji Naiknavare, a partner of Naiknavare Township LLP and premoter of the proposed project, do hereby solemnly declare, undertake and state as under:

1. That has a legal title Report to the land on which the development of the proposed project is to be carried out

## AND

a legally valid authentication of title of such land along, with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

- 2. That the project land is free from all encumbrances except charge of Capital First Limited and IL & FS Trust Company Limited.
- 3. That the time period within which the project shall be completed by the promoter from the date of registration of Eagle's Nest Project-4 is on or before 30.06.2019;
- 4. For ongoing project on the date of commencement of the Act that entire of the amounts to be realized hereinafter by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose, since the estimated receivable of the project is less than the estimated cost of completion of the project.
- 5. That the amounts from the separate account shall be withdrawn in accordance with Rule 5.
- 6. That the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 7. That the promoter shall take all the pending approvals on time, from the competent authorities.
- 8. That the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.

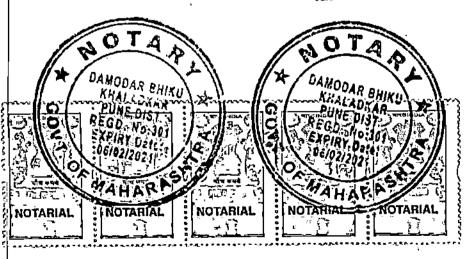
