#### D. Any Qualifications/Observations of CA:

1	The project's commencement date is established in accordance with the RERA Certificate issued by MahaRERA, dated 07th December 2022.	
2	The Total funds collected from allottees have been derived from the unaudited books of accounts, as presented by the management of the promoter. On a comprehensive assessment of the promoter's books of accounts, it has come to light that the promoter is not adhering to the stipulation of maintaining a distinct Designated RERA Bank account for the project, as mandated by Section 4(2)(I)(D) of the Act.	
3	Due to the absence of the designated RERA bank account, to be maintained by the promoter, th determination of amounts withdrawn during the year from designated RERA Bank Account were within th withdrawal limit and the assessment of how the withdrawn funds from the designated RERA Bank Account have been utilized cannot be ascertained.	
4	It has been observed that the commencement certificate for the project has been received till 14th floor for sale building. Therefore advances accepted for non approved units from competent authority has not been considered in Table A.
