- 7. That I, Pavankumar B Chandan shall take all the pending approvals on time, from the competent authorities.
- 8. That I, Pavankumar B Chandan shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.

9. That I, Pavankumar B Chandan have furnished such other documents as have been prescribed by the rules and regulations made under the Act. That I, Pavankumar B Chandan shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
