



## Affidavit cum Declaration

Shree Balaji Homes, a partnership firm incorporated under the Indian Partnership Act 1932 (hereinafter referred to as "Promoter(Developer)" do hereby solemnly declare, undertake and state as under:



- 1. That M/s Shree Balaji Homes has a legal title to the land on which the development of the project "SeasonsPark" is proposed and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

That seventy per cent of the amounts realised by us/promoters for the real estateproject from the allottees, from time to time, shall be deposited in a separateaccount to be maintained in a scheduled bank to cover the cost of construction andthe land cost and shall be used only for that purpose.

- 5. That the amounts from the separate account shall be withdrawn in accordance withRule 5.
- 6. That M/s. Shree Balaji Homes, the promoters shall get the accounts audited within six months after the end ofevery financial year by a practicing Chartered Accountant, and shall produce astatement of accounts duly certified and signed by such practicing CharteredAccountant, and it shall be verified during the audit that the amounts collected for aparticular project have been utilised for the project and the withdrawal has been incompliance with the proportion to the percentage of completion of the project.
  - 7. That M/s. Shree Balaji Homes, the promoters shall take all the pending approvals on time, from the competentauthorities.
  - 8. That M/s. **Shree Balaji Homes**, the promoters shall inform the Authority regarding all the changes that haveoccurred in the information furnished under sub-section (2) of section 4 of the Act andunder rule 3 of these rules, within seven days of the said changes occurring.
  - 9. That M/s. Shree Balaji Homes, the promoters have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
  - 10. That M/s. **Shree Balaji Homes**, the promoters shall not discriminate against any allottee at the time of allotmentof any apartment, plot or building, as the case may be.
