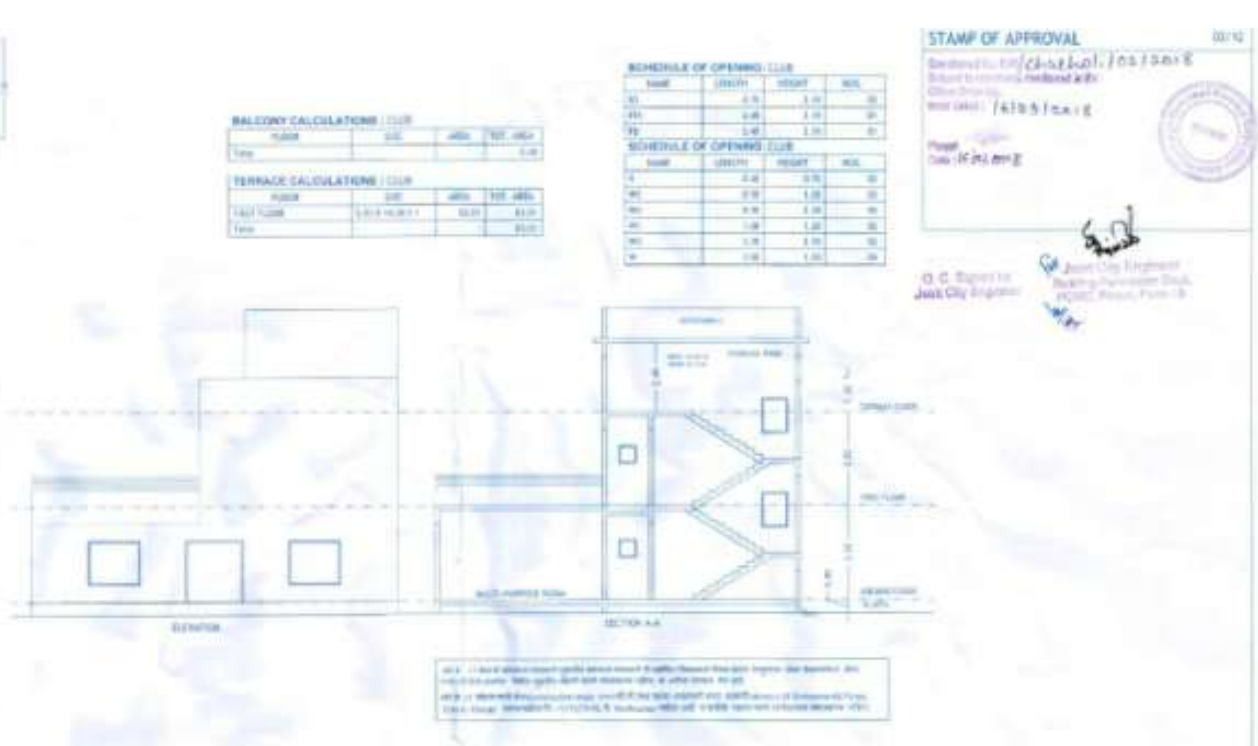
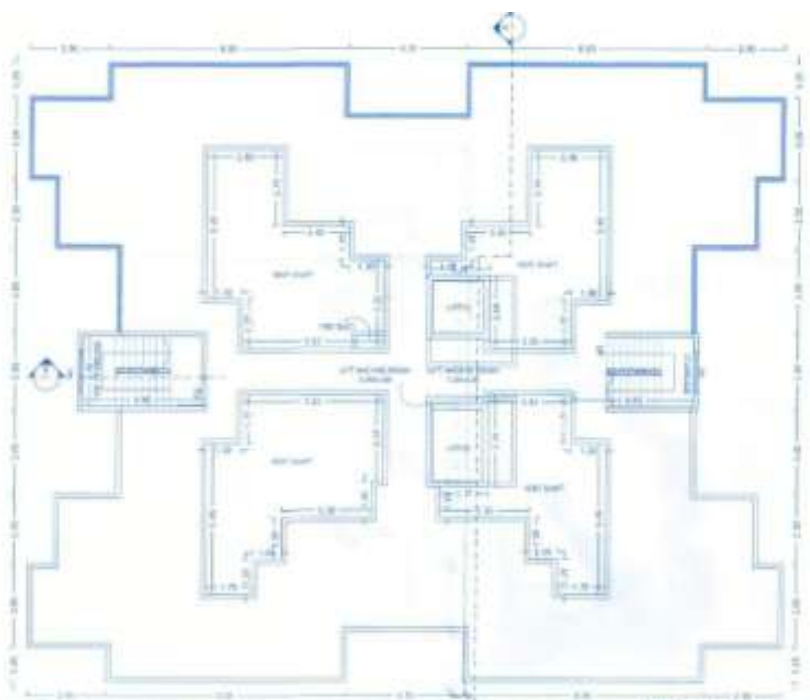
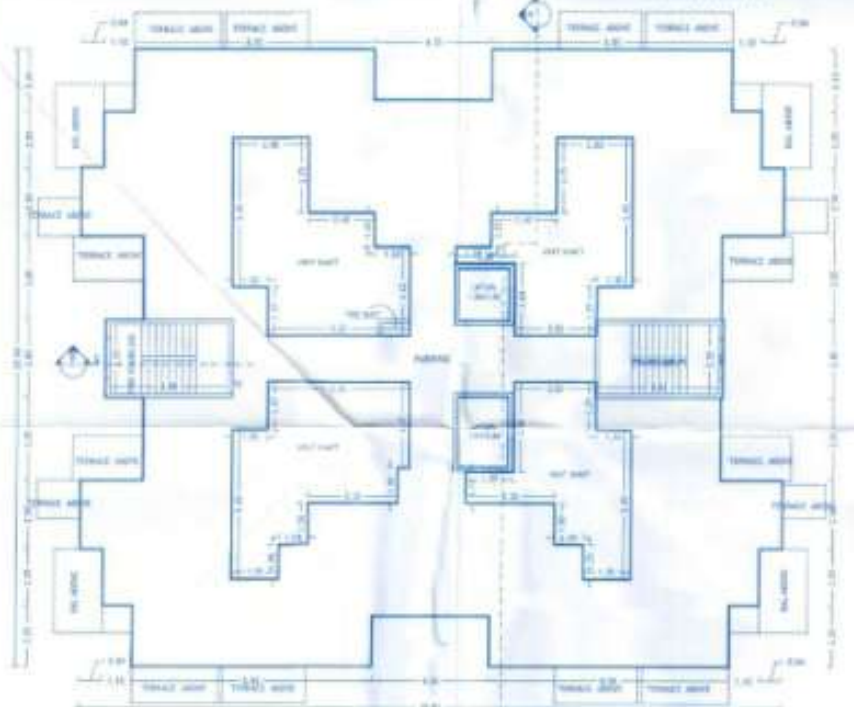


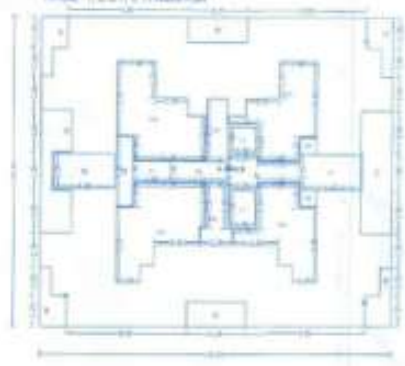




TERRACE FLOOR PLAN

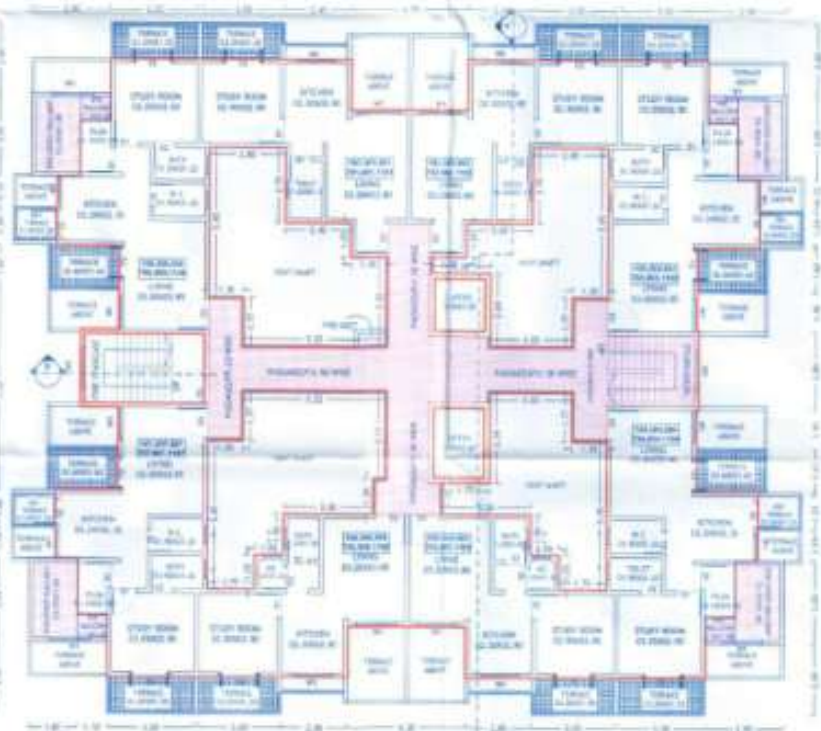


PARKING FLOOR PLAN
