- We have estimated the cost of the completion to obtain Occupancy Certificate/ Completion Certificate, of the Civil, MEP and Allied works, of the Building(s) of the project. Our estimated cost calculations are based on the Drawings/plans made available to us for the project under reference by the Developer and Consultants and the schedule of items and quantity for the



entire work as calculated by <u>Mr. Vishal Raghwani of M/s. Brixwell Engineering</u> as quantity Surveyor*appointed by Developer/Engineer, and the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us.

- We estimate Total Estimated cost of completion of the building(s) of the aforesaid project under reference as Rs. 18,21,04,871/- (Rupees Eighteen Crore Twenty One Lakh Four Thousand Eight Hundred Seventy One Only) (Total of Table A and B). The estimated total cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate/ completion certificate for the building(s) from Municipal Corporation of Greater Mumbai being the planning Authority under whose jurisdiction the aforesaid project is being implemented.
- The Estimated cost incurred till date is calculated at Rs. 6,37,36,704/- (Rs.Six Crores Thirty
 Seven Lakhs Thirty Six Thousand Seven Hundred & Four only). The amount of Estimated Cost incurred is calculated on the base of amount of Total Estimated Cost.
