- 1. That, Promoter has a legal title to the land on which the development of the project is developed.
- 2. That, details of encumbrances of project land being mortgage with the lenders including details of any rights, title, interest or name of any party in or over such land, along with **Edelweiss Asset Reconstruction Company Limited.**
- 3. That the time period within which the project shall be completed by Promoter is 31st December 2027.
- 4.
