2. We estimate Total Estimated Cost of completion of the aforesaid project under reference at Rs. **8,07,40,000/-** (Total of Table A & B) at the time of Registration. The estimated Total Cost of project is with reference to the Civil, MEP, and Allied works required for completion of the apartment sand proportionate completion of internal & external works, as per specifications mentioned in agreement of sale and for the purpose of obtaining occupation certificate/ completion certificate for the Building(s)/ Wing(s) / Layout/ Plotted Development from the **Pimpri Chinchawad Municipal**

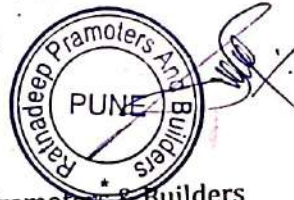
