- 7. The R.C.C. design, calculation & drawing shall be peer reviewed from any other registered structural engineer before re endorsement of C.C of composite building under reference.
- 8. That you shall submit the revised NOC from E.E. (T&C) of M.C.G.M. for parking layout before requesting further C.C to sale wing 'G' & 'H'.
- 9. That you shall submit the revised CFO NOC before requesting for further C.C. for sale wing 'G' or 'H' whichever is earlier.
- 10. That you shall submit NOC from civil Aviation Department before requesting C.C. to sale wing beyond 10th floor.
