and shall produce a statements of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and withdrawal has been in compliance with the proportion to the percentage of completion of the project.

- 8. ThatPromoters shall take all the pending approvals on time, from competent authorities.
- 9. That Promoters have furnished such other documents as have been prescribed by the rules and regulation made under the Act.
- 10. ThatPromoters shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
