Observations and Exceptions

Out of the said amount, a sum of Rs. 35,55,000/-, equivalent to 30%, has been withdrawn from the designated bank account separately and utilised for the project.
- b. An amount Rs. 14,26,514/- has been withdrawn from the designated bank account for which, updated Form 3 is not available. However, the said amount has been utilised for the overall project expenses.
