- 8. That we shall take all the pending approvals on time, from the competent authorities.
- 9. That we shall inform the authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules within 7 days of the changes occurring.
- 10. That we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 11. That we shall not discriminate against any allottee at the time of allotment of any apartment.
