That, the amounts from the separate account to cover the cost of the project shall be withdrawn in proportion to the percentage of completion of the project

- That, the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 7. That, promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project
- 8. That, promoter shall take all the pending approvals on time from the competent authorities.
- That, promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act
- That, promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
