No. 125/1B adm. 2 Hec 43 Ares from Satyavati Anandrao Mankar and Sudakshin Dilip Kothare with consent of Mr. Vinayak Govind Tole and Mohanrao Narayan Joshi by virtue of Sale Deed dated 8/2/1965. Mutation Entry to this effect bears No. 2604 dated 18/9/1965.
- c) That the society prepared and got sanctioned the layout of plots of the above mentioned land i.e. S. No. 125 Hissa No. 1B thereby dividing into residential plots, internal roads etc.
- d) Mr. Prabhakar Parashuram Joshi was the member of the said 'Girija Co-Operative Housing Society'.
- e) That the said society allotted the said plot to Mr. Prabhakar Parashuram Joshi as the member of the owner society and allotted Share Certificate No. 38 having share no. 186 to 190 (both inclusive) Rs. 50/- each.

The said Lease Deed is registered in the office of Sub Registrar Haveli No. 1 at Sr. No. 9061/1988, which lease is for the period of 999 years. Accordingly said society transferred Share Certificate No. 38 in name of Mr. Milind Prabhakar Joshi.
- h) That Mr. Prabhakar Purushottam Joshi executed his Last Will on 9/4/2012 and thereby bequeathed the well defined rights, title and interests in the said plot and membership rights, in percentage to his sons, i.e. Mr. Milind Prabhakar Joshi: 55 % and Mr. Anil Prabhakar Joshi: 45 %. However since the membership rights of the owner society were already transferred to Mr. Milind Prabhakar Joshi as well as the Lease Deed was also came to executed in favour of Mr. Milind Prabhakar Joshi, the provisions in the Will regarding said plot and membership rights were unwarranted. However since the another Legatee Mr. Anil Prabhakar Joshi was co. member of the owner society, the promoters have joined Mr. Anil Joshi alongwith Mr. Milind Joshi for the Development Agreement.
- i) Mr. Prabhakar Purushottam Joshi died on 04/01/2014 and is survived by legatees/ sons i.e. Milind and Anil Prabhakar Joshi and daughters namely Mrs. Madhuri Vilas Kulkarni and Mrs. Anushri Abhijit Degaonkar.
- j) That daughters of late Prabhakar Purushottam Joshi i.e. Mrs. Madhuri Vilas Kulkarni and Mrs. Anushri Abhijit Degaonkar released their share in respect of said plot in favour of Mr. Milind Prabhakar Joshi by virtue of

1) That Developer M/s. Prathamesh Constructions purchased TDR adm. 333.33 Sq. Mtrs. from Kirtiwardhan Developers and Builders by virtue of a Deed of Transfer dated 5/5/2018. The said Deed of Transfer is registered in the office of Sub Registrar Haveli No. 2 at Sr. No. 3948/2018.
