AFFIDAVIT CUM DECLARATION

We, **GENBAJI DEVELOPERS**, having registered office at Gat No. 51/52, Muktai Developers, Vidya Pratishthan Road, Rui, Baramati, Pune - 413133, are promoters of the proposed project "**GENBAJI TOWNSHIP**" located at Plot No. 5 & 6, Gat No. 51 & 52/1, Rui, Baramati, District - Pune, do hereby solemnly declare, undertake and state -

1. That we have a legal title to the land on which the development of the project is proposed.

That we shall get the accounts audited within six months after the end of every financial year by a practicing chartered accountant, and shall produce a statement of accounts duly certified and signed by practicing chartered accountant, and it shall be verified during audit that amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion of the percentage of completion of the Project.
8. That we shall take all the pending approvals on time, from the competent authorities.
9. That we shall inform the authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules within 7 days of the changes occurring.
10. That we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.

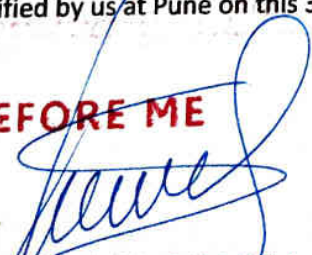
