Empire Industries Ltd as the Lessee of the other part, the said Maharashtra Industrial Development Corporation had leased of all that piece and parcel of open plot of land bearing Plot No. 22, admeasuring 1,41,402 sq. meters., situated at Ambernath Industrial Area, Village Chikhloli, Taluka Ambernath, District Thane, for a period of 99 years to M/s. Empire Industries Ltd, for a consideration and on the terms and conditions contained therein.
