3. We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as Rs. 1,38,01,843 (Total of Table A and B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the building(s) from the PCMC being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.

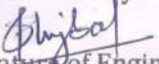
