- 8) If in the development permission reserved land/amenity space/road widening land is to be handed over to the authority in the lieu of incentive FSI, if any, then necessary registered transfer deed shall be executed in the name of authority with in 6 month from the commencement certificate.
 - 9) All the provision mentioned in UDCPR, as may be applicable, shall be binding on the owner/developer
 - 10) Provision for recycling of Gray water, where ever applicable shall be completed of the project before completion of the building and documents to that if at shall be submitted along with the application form of occupancy.
 - 11)Areas/cities where storm water drainage system exists or designed, design and drawings from Service consultant for storm water drainage should be submitted to the concerned department of the authority before Commencement of the work and completion certificate of the consultant and NOC from strom water Dept. in this regard shall be submitted along with the application for occupancy certificate.
 - 12)Lift Certificate from PWD should be submitted before Occupation Certificate, if applicable
 - 13) Permission for cutting of tree, if necessary, shall be obtained from the tree authority. Also the certificate/letter for plantation of trees on the land, if required under the provision of tree act, shall be submitted before occupation certificate.
 - 14) Condition mentioned in Permission C.C. TMC/TDD/3474 Dated 07.10.2020 will be binding on developer.
 - 15) N.O.C. from water dept. and drainage dept. should be submitted before O.C.
 - 16) The proposed building should be structurally designed by considering seismic forces as per I.S. Code No.1893 & 4326 & certificate of structural stability should be submitted at the stage Intimation of plinth & Occupation Certificate.
 - 17) CCTV System shall be installed before applying for occupation certificates.
 - 18) Rain water harvesting system should be installed before applying for occupation certificates.
 - 19) Solar Water heating system should be installed before applying for occupation certificates.
