Gokhale & Asso have undertaken assignment of certifying Estimated Cost for the Subject Real Estate Project proposed to be registered under MahaRERA, being **ONE** Building situated on the plot bearing **Plot no 79,SECTOR 55** of **village DRONAGIRI taluka URAN District RAIGAD PIN 400 702 admeasuring 1449.98** sq.mts. area being developed by M/S Infinity Builders And Developers.

- 1. Following technical professionals are appointed by Owner / Promoter:-
 - (i) M/TRIARCH DESIGN STUDIO as L.S. / Architect;
 - (ii) M/s A.G. Gokhale & Asso as Structural Consultant
 - (iii) M/s NOT APPOINTED as MEP Consultant
 - (iv) M/s RAMESH SOUMBE as Quantity Surveyor *
- 2. We have estimated the cost of the completion to obtain Occupation Certificate/Completion Certificate, of the Civil, MEP and Allied works, of the Building(s) of the project. Our estimated cost calculations are based on the Drawings/plans made available to us for the project under reference by the Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by RAMESH SOUMBE quantity Surveyor* appointed by Developer/Engineer, and the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us.
- 3. We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as Rs_ 13.85 Cr (Total of Table A and B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the building(s) from the CIDCO being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.

- 4. The Estimated Cost Incurred till date is calculated at Rs. 1.20 cr/- (Total of Table A and B)_. The amount of Estimated Cost Incurred is calculated on the base of amount of Total Estimated Cost.
- 5. The Balance cost of Completion of the Civil, MEP and Allied works of the Building(s) of the subject project to obtain Occupation Certificate / Completion Certificate from CIDCO (planning Authority) is estimated at Rs 12.65 Cr (Total of Table A and B).
