2. I have estimated the cost of the completion to obtain Occupation Certificate / Completion Certificate, of the civil MEP and Allied work, of the building of the project. Our estimated cost calculation are based on the drawings/ plans made available to us for the project under reference by the Developer and consultants and the schedule of items and quantity for the entire work as calculated by **Mr.Kalpesh Manani (Engineer)** appointed by Developer, and the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by me.
3. The total estimated cost of completion of the building of the aforesaid project under reference as **Rs.11,00,00,000/- (Total of Table A)** . The estimated total cost of project is with reference to the civil, MEP, and Allied work required to be completed for the purpose of obtaining occupation certificate for the building from the PMC (Pune Municipal Corporation) being the planning authority under whose jurisdiction on the aforesaid project being implemented
4. The estimated cost incurred till date is calculated at **Rs.70,00,137/- (Total of Table A)** .The amount of estimated cost incurred is calculated on the base of amount of total estimated cost.
5. The balance cost of completion of the civil ,MEP and allied work of the building of the subject project to obtain Occupation Certificate / Completion Certificate from PMC (Pune Municipal Corporation) (Planning Authority) is estimated at **Rs.10,29,99,863/- (Total of A)**.
