If construction is not commenced this commencement certificate isrenewable every year but such extended period shall be in no case exceed three years provided further that such laps shall not bar any subsequentapplication for fresh permission under section 44 of the MaharashtraRegional and Town Planning Act, 1966.
- 6. This Certificate is liable to be revoked by the VP & CEO / MHADA if:
- a. The development work in respect of which permission is grantedunder this certificate is not carried out or the use thereof is not in accordance with the sanctioned plans.
- b. Any of the condition subject to which the same is granted or any of the restrictions imposed by the VP & CEO / MHADAis contravened or not complied with.
- c. The VP & CEO / MHADAis satisfied that the same is obtained by the applicant through fraud ormisrepresentation and the appellant and every person deriving titlethrough or under him in such an event shall be deemed to have carried out the development work in contravention of section 43 and 45 of the Maharashtra Regional Town Planning Act, 1966.
- 7. The conditions of this certificate shall be binding not only on the applicant but on his heirs, executors, assignees, administrators and successors andevery personderiving title through or under him.
