(Affidavit cum Declaration)

9. I say and declare that the promoter have furnished such other documents as have been prescribed by the rules and regulations made under the Act.

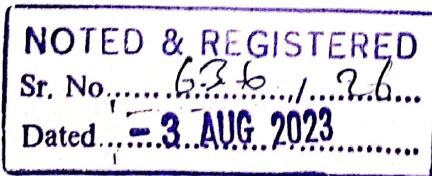
10. I say and declare that the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
