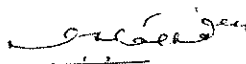
- (a) Layout and the Building/s plan are revised *vide* Commencement Certificate No.CC/2627/2020 dated 28.01.2020, (ii) Commencement Certificate No.CC/0113/21 dated 15.04.2021 issued by the Municipal Corporation of City of Pune.
- (b) The matter pertaining to Special Civil Suit No.475/1998 filed by one S. A. Inamdar; the Plaintiff *inter alia* against the said Owner and Cavalcade Properties Private Limited, added later on as the Defendant No.6 and the Defendant No.7 respectively, seeking specific performance of the alleged agreement of the year 1992 relating to Survey Nos.27/4, 42/1/B situate at village Mohammedwadi of City of Pune, has already been mentioned on page Nos.12 to 14 of the said Title Report dated 12.05.2016 is settled. Accordingly, the Plaintiff filed application under Order 23, Rule 1 of the Civil Procedure Code, 1908 at Exh.168 unconditionally withdrawing the suit. The said withdrawal has been allowed by the Hon'ble Court by its order on Exh.1 dated 15.06.2021.
- (c) As mentioned in the said Title Report, the Owner had mortgaged the portions and/or some of the buildings constructed on the said Land to the Housing Development Finance Corporation Limited (HDFC) as security for refund of the loan availed by it and the other borrowers Paradigm Logistics & Distribution Private Limited and Novel Properties Private Limited. By the instruments styled as the Deed of Partial Release of Mortgage, the HDFC redeemed and released their charge on the portions and the buildings constructed on the said Land:

- (d) It is seen that from the Office Order dated 15.01.2020 bearing Outward No.MC/SEC/205/358 issued under the signature of the Hon'ble Commissioner, Pune Municipal Corporation pursuant to Resolution No.1111 dated 23.01.2019, passed in the General Body Meeting of Pune Municipal Corporation the shifting of the road from Survey Nos.25, 27 and 28 to Survey Nos.25 and 26 under section 205 of the Maharashtra Municipal Corporation Act and for slight shifting of the reservation of Primary School (PS76) under Rule as provided for in Rule 15.10 of DCPR 2017 have been approved.
- (e) As mentioned in the said Title Report, the said Owner has filed a petition bearing Writ Petition No.5647/2016 in the High Court of Judicature at Bombay for reliefs pertaining to reserving the portions for DP Road through the said Land. Though the said writ petition is yet to come up for admission, since the PMC has shifted the DP Road, the reliefs sought in the writ petition may have become redundant.
- (f) The said Owner and other filed RTS Appeal 119/2020 for deletion of Mutation Entry No.14839 carried to VF 7/7A/12 of Survey Nos.27/1B+2+3 and 27/4 in the other rights column, levying royalty and penalty thereon of the amount of Rs.1,01,52,223/- for unauthorized minor mineral extraction before the Sub-Divisional Officer Haveli, Pune Sub-division Pune. However, the said appeal came to be dismissed on 09.10.2020. Against the said dismissal, the said Owner has filed second appeal before the Collector, Pune, bearing RTS 2nd Appeal No.38/2021 which is yet pending.
