10. That I shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.

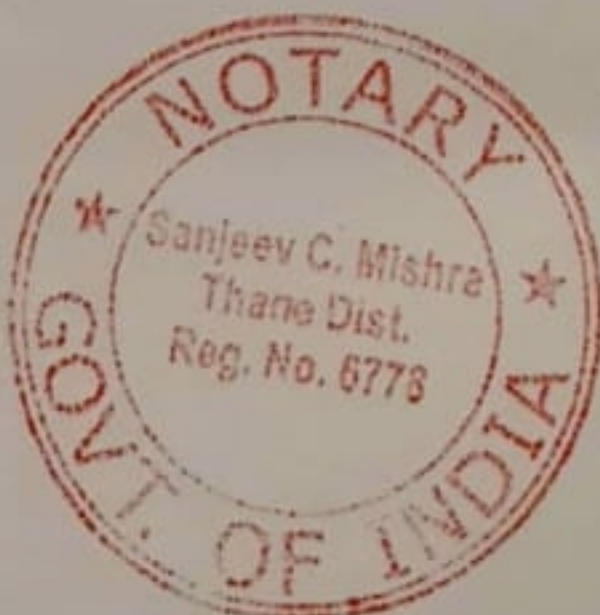

AFFIDAVIT CUM DECLARATION OF PROMOTER

I, Naresh A Musale promoter of the new Project do hereby solemnly declare, undertake and state as under:
