That I have a legal title to the land on which the development of the proposed project is to be carried out.

- 2. That the project land is free from all encumbrances
- That the time period within which the project shall be completed by the Promoter from the date of registration is **December 2025**.
- 4. That seventy percent of the amount to be realized hereinafter by us for the real estate project from the allotees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amount from the separate account shall be withdrawn in accordance with Rule 5.
- 6. That the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts dully certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 7. That the promoter shall take all pending approvals on time, from the competent authorities.
- 8. That the promoter shall inform the Authority regarding all changes that have occurred in the information furnished under Sub-section [2] of Section 4 of the Act and under Rule 3 of these rules, within seven days of the said changes occurring.
- That the Promoter has furnished such other documents as have been prescribed by the Rules and Regulations made under the Act.
- 10. That the promoter shall not discriminate against any allotee at the time of allotment of any apartment, plot or building, as the case may be.
