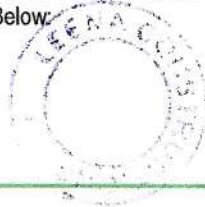

Our estimated cost calculations are based on the drawings/plans made available to us for the project under reference by the developer/ consultants. The schedule of items and quantity required for the entire work as calculated by a Quantity surveyor* appointed by Developer/Engineer, the assumption of the cost of material, Labour and other inputs made by developer, and the site inspection carried out by us to ascertain/ confirm the above analysis given to us.
3. We estimated Total Estimated cost of completion of the aforesaid project under reference at **Rs. 18.00 Crs** (Total of Table A and B) at the time of registration.
