Affidavit cum Declaration

Affidavit cum Declaration of Dilip Shivanand Kotibhaskar, duly authorized Director of Kotibhaskar Infrastructures & Developers Private Limited & duly authorized by the promoter of proposed project, vide its authorization dated 28.02.2022.

- I, Dilip Shivanand Kotibhaskar, duly authorized promoter of the proposed project does hereby solemnly declare, undertake and state as under:
- 1.That I have legal title to the land on which the development of the project is proposed

- a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by me is 30.10.2025.

That I Dilip Shivanand Kotibhaskar, promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

- 8. That I Dilip Shivanand Kotibhaskar, promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That I, Dilip Shivanand Kotibhaskar, promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That I Dilip Shivanand Kotibhaskar, promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
