- 3. We estimate Total Estimated Cost of completion of the Two wings of the aforesaid project under reference as **Rs 4,50,74,270** (Total of Table A+B). The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the all wings from the Kalyan-Dombivali Mahanagar Palika is being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
