7. That I/the promoter shall inform the authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the act and under rule 3 of these rules, within seven days of the said changes occurring.

8. That the promoter has furnished such other documents as have been prescribed by the rules and regulations made under the ACT.



9 That the promoter shall not discriminate any allottee at the time of allotment of any apartment, plot or building, as the case may be
