

In SRO No. 1 & 4 record of Index II from January 2015 to till this date is sent for binding. Hence not ready for inspection. In SRO No. 2, 3 & 5 record of Index II from January 2017 to till this date is not ready for inspection. Hence were not available for perusal.

- II) Many register books kept for search at the SRO Panvel are tornd and were found in a very critical and scattered position. Some pages are very light and unclear printing, thus whitening Index II not reading properly. Some register pages are misplaced hence were not available for perusal.
- III) This report is subject to on the basis of the record made available for search in the office of SRO Panvel at that time.
- IV) This search report is subject to badly torned and mutilated record of Index-II which is available in the office of Sub- registrar of assurances of Panvel.
