Affidavit cum Declaration of Mr./Ms. ADITYA ASSOCIATES promoter of the proposed project "ADITYA ONE" duly authorized by the promoter of the proposed project, vide its/his/their authorization dated

I, M/S ADITYA ASSOCIATES Through Mrs. Avantika Sanjay Baviskar, promoter of the proposed project / duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as unsder:S

1. That I / promoter have / has a legal title to the land on which the development of the project is proposed

have/has a legal title to the land on which the development of the proposed project is to be carried out

AND

- 6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

- 7. That I / promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- & That I / promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That I / promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

10. That I / promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
