

AFFIDAVIT CUM DECLARATION

Affidavit cum declaration of Mr. Baban Vitthal Marne, Mr. Sagar Baban Marne & Mr. Sandeep Ram Pawale of M/s. A.V. Corporation of the proposed **project VITTHAL EMPIRE PHASE** - II do hereby solemnly declare, undertake & state as under:





 That the promoter has a legal title Report to the land on which the development of the project is proposed.

A Legally valid authentication of the title of such land along with an authenticated copy of the agreement between such owner & promoter for development of the real estate project is enclosed herewith.

- 2. That the project land is free from all encumbrances.

- 4. (a) For New Project
 That 70% of the amount realized by promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction & the land cost shall be used only for that purpose
- 5. That the amounts from the separate account shall be withdrawn in accordance with Rule 5.
- 6. That the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, & shall produce a statement of accounts duly certified an signed by such practicing chartered Accountant, and it shall be verified during the audit that the amounts collected for articular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 7. That Promoter shall take all the pending approvals on time, from the competent authorities.
- 8. That the promoter shall inform the Authority regarding all the changes that have accurred in the information furnished under sub-section (2) of section 4 of the Act & under rule 3 of these rules, within 7 days of the said changes accurring.
- That the promoter have furnished such other documents as have been prescribed by the rules & regulations made under the Act.
- 10. That the promoter shall not discriminated against any allottee at the time of allotment of any apartment, plot of building, as the case may be.
