Ans: No. The SHPL has collected Rupees 1,26,46,400/- from the flat purchasers before opening of the designated bank account. As explained to us, at the time of booking of flats, the designated account was not opened and flat purchasers are in hurry to do the registration to

take the benefit of reduced stamp duty scheme which was about to expire by 31<sup>st</sup> March 2022. As explained by the Promoters, after obtaining consent letters from these flat purchasers about the deposit of their amount into bank account other than the designated account, the amount is collected from them and deposited into the other operative account and after opening of the designated bank account the balance in the said bank account, which was Rupees 13,64,900/deposited on 29/03/2022 in the RERA Escrow Account (Type One) and the entire amount was then transferred to the SHPL's current account (Type Three) wherein 30% collection amount is to be transferred as per the scheme. The SHPL has already obtained a certificate in Form 3 dated 9<sup>th</sup> March 2022 from a Chartered Accountant that it was eligible to withdraw Rupees 12,92,63,095/- from the designated bank account.
