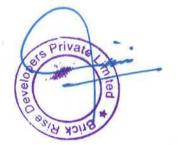

- 3. That the Promoter has a legal title over the land on which the development of the Project is proposed.
- 4. The receivables of Phase- 1 Project is proposed to be hypothecated in favour of IndusInd Bank Ltd., Barakhamba Road Branch, New Delhi-110001 by way of first charge including sold and unsold units on the land admeasuring 26,536.17 sq. mtrs. situated at Plot No.SC -02/H & I, Sector 150, Noida excluding development management fee.
- 5. That the time period within which the Project shall be completed by the Promoter is **31**st **March 2024**.
- 6. That 70% (seventy per cent) of the amounts realized by the Promoter for the real estate Project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and the said amount shall be used only for that purpose.
- 7. That the amount from the separate account, to cover the cost of the Project, shall be withdrawn in proportion to the percentage of completion of the Project.
- 8. That the amounts from the separate account shall be withdrawn only after it is certified by an engineer, an architect and a practicing chartered accountant and that the withdrawal will be in proportion to the percentage of completion of the Project.
- 9. That the Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular Project have been utilised for the Project and the withdrawal has been in compliance with the proportion to the percentage of completion of the Project.
- 10. That the Promoter shall take all the pending approvals on time, from the competent authorities.





- 11. That the Promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 12. That the Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
