I Rajesh Jujare have undertaken assignment of certifying Estimated Cost for the Subject Real Estate Project "Vertical Alcinia" proposed to be registered under MahaRERA, being Building C situated on the Plot bearing Survey no.12 , Hissa No. 8/A /1+2+3 demarcated by its boundaries (latitude and longitude of the end points) to the North S.No 12(P), to the South Proposed 18.00M wide Road, S.No 12(P),to the East S.No 11 to the West S.No 12(P) of Division-Pune, village-Mohammad wadi, Taluka- Haveli District-Pune, PIN- 411028 admeasuring 940.40 sq.mts. area being developed by Hashthshilp Realty.

1. Following technical professionals are appointed by Owner / Promoter :-

- (i) M/s **Tripti Gupta-Hawaladar** as L.S. / Architect ;
- (ii) M/s **Sunil Mutalik & Associates** as Structural Consultant ;
- (iii) M/s **McLIN CONSULTANTS PVT. LTD.** as MEP Consultant ;
- (iv) Mr. **Rajesh Jujare** as Quantity Surveyor .

2. We have estimated the cost of the completion to obtain Occupation Certificate/ Completion Certificate, of the Civil, MEP and Allied works, of the Building of the project. Our estimated cost calculations are based on the Drawings/plans made available to us for the project under reference by the Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by Shri Rajesh Jujare, Quantity Surveyor* appointed by Developer/Engineer, and the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us.

3. We estimate Total Estimated Cost of completion of the building of the aforesaid project under reference as **Rs. 15,35,68,464 /-** . The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate/completion certificate for the building(s) from the PMRDA, being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.

4. The Estimated Cost Incurred till date is calculated at **Rs. 17,50,000 /-**. The amount of Estimated Cost Incurred is calculated on the base of amount of Total Estimated Cost.

5. The Balance cost of Completion of the Civil, MEP and Allied works of the Building(s) of the subject project to obtain Occupation Certificate/Completion Certificate from PMRDA, (Planning Authority) is estimated at **Rs 15,18,18,465/-**.

6. I certify that the Cost of the Civil, MEP and allied work for the aforesaid Project as completed on the date of this certificate is as given in Table A and B below :
