

That we developers shall get the accounts audited within six months after the end of every figancial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project .

- 8. That the developers shall take all the pending approvals on time from the competent authorities.
- 9. That the developers have furnished such other documents as have been specified by the rules and regulations made under the Real Estate (Regulation and development) Act , 2016.
