

## Affidavit cum Declaration

I Mr.Arjun Ashok Tarachandani Proprietor of the Firm Jupiter Construction Company Builders & Developers Promoter of the Project "JUPITER GALAXY" do hereby solemnly declare, undertake and state as under:

- I have the legal title report to the land on which the development of the project is proposed.
- 2. The Project land is free from all encumbrances.



- 3. That the time period within which the project shall be completed by me shall be me on or before 31st DECEMBER 2022.
- 4. Seventy Percent of the amounts to be realised hereinafter by **me** for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. The amount from separate account shall be withdrawn in accordance with RERA rule 5.
- 6. I shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 7. I shall take all the pending approvals on time, from the competent authorities.
- 8. I shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) OD section 4 of the ACT and under rule 3 of these rules, within seven days of the said changes occurring.
- 9. I have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. I shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
