The Schedule of Items & Quantity required for the entire work as calculated by us appointed by the Developer/Engineer, the assumption of the cost of material, labour & other inputs made by the Developer, and the Site Inspection carried out by us to ascertain / confirm the above analysis given to us.
3. We estimate Total Estimated Cost of completion of the aforesaid Project mentioned under reference at **Rs.12,25,00,000/- (Rupees Twelve Crore Twenty Five Lacs Only)** (Total of Table A & B) at the time of Registration.
