- c. It further transpires from the revenue record that the Mamlatdar, Vadodara had passed an order to Consolidate R. S. no. 498 & 500, vide order no. 13/58 and Consolidated new R. S. no. 498 had been allotted and the mutation entry to that effect had been affected in revenue record vide entry no. 1016 on dtd.08/12/1959.
- d. It further transpires from the revenue record that due to oral family partition amongst brothers the land bearing R.S. no 498 admeasuring Acre 1 18 Guntha land was transferred and mutated in the name of Govindbhai Naranbhai Amin and the mutation entry to that effect had been affected in revenue record vide entry no. 1850 on dtd.22/06/1965.
- e. It further transpires from the revenue record that due to oral family partition the land bearing R.S. no 501/1 admeasuring Acre 2 20 Guntha land was transferred and mutated in the name of Pushpaben Govindbhai Amin and the mutation entry to that effect had been affected in revenue record vide entry no. 2220 on dtd.31/05/1970.

- f. It further transpires from the revenue record that the Mamlatdar, Vadodara had passed an order to Consolidate R. S. no. 498 & 501/1, vide order no. Jamin/Vashi/2111/92 and Consolidated new R. S. no. 498 had been allotted and the mutation entry to that effect had been affected in revenue record vide entry no. 4406 on dtd.16/05/1992.
- g. It further transpires from the record that Govindbhai Naranbhai Amin & Pushpaben Govindbhai Amin through their power of attorney Jayeshbhai Maheshbhai Amin have sold the land bearing R.S. no. 498 paikee 5,868 Sq. M. land on eastern portion i.e. captioned land to Smt. Alpaben Maheshbhai Amin, Savitaben Maheshbhai Amin, Dipakbhai Bhagubhai Patel (HUF), Kalpeshbhai Bhagubhai Patel (HUF), Jayeshbhai Maheshbhai Amin vide registered sale deed no. 3444 on dtd.15/03/2008 and the mutation entry to that effect had been affected in revenue record vide entry no. 6865 on dtd.19/03/2008.
- h. It further transpires from the record that Govindbhai Naranbhai Amin was died on dtd.28/09/2012 and on his demise, the name of his legal heirs Pushpaben Govindbhai Amin & Hiteshbhai Govindbhai Amin were mutated in revenue record by virtue of succession and the mutation entry to that effect had been affected in revenue record vide entry no. 8387 on dtd.19/10/2012.

It further transpires from the revenue record that the name of Nayanaben Hiteshbhai Amin, Palak Hiteshbhai Amin & Payal Hiteshbhai Amin were mutated in revenue record as co-owners of the said land and the mutation entry to that effect had been affected in revenue record vide entry no. 8444 on dtd.30/01/2013.
- j. It further transpires from the revenue record that due to family partition the land bearing R.S. no 498 paikee 1 admeasuring 2,833 Sq. M. land on northern portion was transferred and mutated in the name of Hiteshbhai Govindbhai Amin and the land bearing R.S. no 498 paikee 1 admeasuring 5,784 Sq. M. land on southern portion was transferred and mutated in the name of Pushpaben Govindbhai Amin & others and the mutation entry to that effect had been affected in revenue record vide entry no. 8704 on dtd.26/12/2013.
- k. It also further transpires that the Collector, Vadodara had passed an order to use the said land for non agriculture purpose vide his Order no.: N.A./S.R./584/2014-15, No. Jamin/D/Kalam 65/Vashi/ 9193 to 9201/14, dtd.10/11/2014 and Order no.: N.A./S.R./488/2014-15, No. Jamin/D/Kalam 65/Vashi/ 9291 to 98/14, dtd.10/11/2014 and Vadodara Mahanagar Seva Sadan had sanctioned Development Permission vide raja chithi no. Ward-7/L-53/2015-2016 dtd.30/07/2015.

- 1. Hence it is crystal clear that Hiteshbhai Govindbhai Amin & others are the owners and in possession of the captioned land.
- m. It also further transpires that Hiteshbhai Govindbhai Amin had executed Development Agreement in favor of M/s. Shreeji Corporation, a partnership firm regarding the land bearing R.S. 498 paikee 1 registered before Vijay D. Panchal, Notary Public vide Sr. no. 7120, dtd.21/08/2014.
- n. It also further transpires that Pushpaben Govindbhai Amin & others have executed Development Agreement in favor of M/s. Shreeji Corporation, a partnership firm regarding the land bearing R.S. 498 paikee 1 paikee 1 registered before Vijay D. Panchal, Notary Public vide Sr. no. 7122, dtd.21/08/2014.
- 3. I have also issued a Public Notice dtd.07/10/2015 in Gujarat Samachar, Gujarati daily for inviting objections against issuance of Title Clearance Certificate in respect of the captioned land. However, I have not received any objections or claims in response to the Public Notice till today.
- 4. I have also caused a search to be made with the Sub Registrar at Vadodara for the year 1985 to 2015 as available record and I could not find any charges or encumbrances having been registered with the Sub-Registrar at Vadodara.
