1. I **ATUL V. KUDTARKAR** have undertaken assignment of certifying Estimated Cost for **"Deep Nirvana - Building No. 1 (Wing A & B), Building No. 2 & 3"** having MahaRERA Registration Number **P51700048358** being developed by **M/s. Deepali Infra Projects.**
2. We have estimated the cost of civil. MEP and allied works required for completion of the apartments and proportionate completion of internal & external works of the project as per specifications mentioned in agreement of sale. Our estimated cost calculations are based on the drawings plans made available to us for the project under reference by the Developer / Consultants. The Schedule of items and quantity required for the entire work as calculated by **Mr. Ganesh Shingare** Quantity Surveyor* appointed by Developer / Engineer, the assumption of the cost of material labour and other inputs made by developer and the site inspection carried out by us to ascertain / confirm the above analysis given to us.



3. We estimated (Total of Table A and B) at the time of Registration. The estimated Total Cost of project is **Rs.45,78,69,181/- (Excluding GST)** with reference to the Civil, MFP and Allied works required for completion of the apartments and Proportionate completion of internal & external works, as per specifications mentioned in agreement of sale and for purpose of obtaining occupation certificate /completion certificate for the Building(s) / Wing(s) / layout / Plotted Development from the **Kalyan Dombivali Municipal Corporation** being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
4. The Estimated cost incurred till date is calculated at **Rs.7,65,81,931/- (Excluding GST)** (Total of Table A and B). The amount of Estimated Cost Incurred is calculated on the basis of input materials / services and units cost of these items.
5. The Balance Cost of Completion of the Civil, MEP and Allied works for completion of the apartments and proportionate completion of internal & external works, as per specifications mentioned in agreement of sale, of the project is estimated **Rs.38,12,87,250/-(Excluding GST)** (Total of Table A and B)

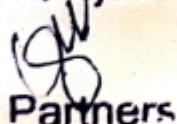
