Affidavit cum Declaration

Affidavit cum Declaration of **Shri. Rajesh Ganeshrao Hiwase**, Authorised Partner of M/s **Radiance Infraventure**, promoter of the proposed project "Sai Krishna Residency" vide Development Agreement Deed Dt: 11th day of February 2019.

I, **Rajesh Ganeshrao Hiwase**, authorized partner of the proposed project / duly authorized by the partners of the proposed project do hereby solemnly declare, undertake and state as under:

1. That We have a legal title to the land on which the layout of the project is proposed

AND

We legally have valid authentication of title of such land along with an authenticated copy of the agreement and sale deed between the owner and promoter for the land/layout is enclosed herewith.

2. That the said property is free from all encumbrances including details of any rights, title, interest or name of any party in or over such land.



3. That the time period within which the layout shall be completed by us is March 2022.
4. That seventy per cent of the amounts realized by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That we shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That we shall take all the pending approvals on time, from the competent authorities.
9. That we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.

10. That we shall not discriminate against any allottee at the time of allotment of any plot, as the case may be, on any grounds.
