- 8. That M/s Concept Builder and Developersshall inform the Authority regarding all the changes that have occurred in the information furnished under sun-section (2) of section 4 of the act and under rule 3 of these rules, within seven days of the said changes occurring.
- That M/s Concept Builder and Developershas furnished such other documents as have been prescribed by the rules and regulations made under the act.
