Within the Registration District of Satara and Sub district Satara the property is situated at Peth Vyankatpura, Tal. And Dist. Satara bearing City Survey No. 178 having total area 936.65 sq. mtrs. in which constructed area of this property is adm. 514.68 sq. mtr. The property bearing CTS No. 178 is bounded as follows -

- 5) Brief history of devolution of the title -

I have taken e-search of the property of last 30 years at the office of Sub Registrar, Satara. The title flow of the property of last 30 years is given in this report as below.

The subject property is originally part and parcel of City Survey No. 178 situated at Vyankatpura Peth, Satara, Tal. and Dist. Satara. The said property was originally belonging to late Hari Govind Phatak. He had Four sons viz., Govind, Gopal, Vaman and Bhalchandra. Hari died on 10/04/1941 and thereby name of his son Govind Hari Phatak was entered in to City Survey Record as joint family manager. Thereafter, Govind Hari Phatak was died on 15/10/1969. After the death of Govind the name of his legal heirs viz., wife Jayantabai and brothers Gopal, Vaman and Bhalchandra were recorded to the City Survey Record on 25/11/1969.

On 08/01/1984, Bhalchandra Hari Phatak was died. At the same time Vaman and Jayantabai Govind Phatak who happened to the wife of Govind relinquished their share in favour of Gopal Hari Phatak. In view of this, the name of Jayantabai Gopal and Bhalchandra were removed from the City Survey Record and only the name of Gopal Hari Phatak was maintained.

On 21/02/1989, Smt. Jayantabai was died. She bequeathed her share in the property in question to her nephew by registered Will and thereby the names of beneficiaries of the Will viz., Shrikant Vaman Phatak and Vasant Vaman Phatak were entered in to City Survey Record.

The name of his widow Sushila Vaman Phatak was entered in to City Survey Record as joint family manager On 25/08/1993 as her husband Vaman Hari Phatak was died. After the death of Gopal the names of his legal heirs viz., widow Sudhatai and sons and daughter Manohar Gopal Phatak, Vinayak Gopal Phatak and Saroj Laxman Gole were



recorded to the City Survey Record on 11/08/2000. Further, Sudhatai died on 20/04/2007 and thereby her name from the City Survey Record was deleted.

On 21/01/2013 Sushila Vaman Phatak was died and thereby the names of her legal heirs viz., Shrikant Vaman Phatak, Vasant Vaman Phatak and Nalini Ravindra Gosavi were recorded to the City Survey Record.

In the year 2018, the co owners in the Phatak family decided to make a partition and accordingly Registered Partition Deed was registered at Deed Sr. No. 3532/2018 dt. 18/06/2018. Accordingly, the effect of Partition was mutated on 26/11/2018 to the City Survey Record.

On 29/05/2019, all the co owners sold out the property in question to the present owner vide Registered Sale Deed No. 1932/2019 dt. 29/05/2019 for the total consideration of Rs. 2,01,64,323/-. This sale transaction was entered in to City Survey record by Mutation Entry dt. 29/07/2019 and accordingly the names of Phatak family were removed and the name of present owner i.e. Swaroop Niketan through its Partners was recorded to the City Survey record.

By virtue of Sale Deed dt. 29/05/2019, the Swaroop Niketan has become absolute owner of the property in question.

I found no encumbrance on the property while taking a search of last 30 years.

I have verified all the documents produced by present proponent and they are found genuine and in order.
