



- 1. The said land is free from all encumbrances.
- 2. The time period within which the project shall be completed by promoter is 19.12.2022.
- Seventy percent of the amounts realised by promoter for the real estate project from the allottees from time to time, shall be deposited in a separate account to be maintained in a sheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
